The difference between the two types of share historically was that the CLC shares ranked for the dividend paid on 26 July 2018 and the CLCN shares did not. As the dividend has now been paid, the shares are now identical and application has been made to the London Stock Exchange and to the UK listing Authority for all shares to trade under TIDM CLC and for CLCN to be withdrawn. The shares allotted on 2 August 2018 will trade under TIDM CLC.
